



Terms & Conditions

As Shopological is based in England, and the Shopological service Site is made available to users from there, these Visitor Terms shall be governed by English law.

The following terms and conditions govern all use of the Shopological website and/or mobile application and all content, services and products available at or through the website. The Website and/or mobile application is owned and operated by Shopological Ltd. ("Shopological"). The Website and/or mobile application is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Shopological's Privacy Policy) and procedures that may be published from time to time on this Site by Shopological (collectively, the "Agreement").
